

RANDOLPH COUNTY COMMISSION MINUTES
Thursday, February 23, 2012

The Honorable Commission convened at the Huntsville Courthouse with the following present: Susan Carter, Presiding Commissioner; Jerry Crutchfield, Western District Commissioner; and Shelby Creed, Deputy Clerk. Wayne Wilcox, Eastern District Commissioner, was absent due to a death in the family.

9:00 a.m. Com. Carter called the meeting to order and moved approval of the agenda. Com. Crutchfield seconded and motion passed (2-0).

Com. Carter received a call from Janet Murray, Randolph County Health Department, to inform Commissioners she will be meeting soon with the Onsite Wastewater Sewer Board to review revisions of the sewer ordinance.

Com. Crutchfield contacted Road and Bridge Supervisor Mike Rogers to discuss a complaint from Bob Kern, CR 2905/Route A of damage to a fence.

Com. Crutchfield returned a call to Bob Kern, CR 2905, to discuss damage to his fence from a county mower. Commissioners informed him they will inspect the reported damage.

Com. Crutchfield reported on the progress meeting Thursday morning with Septagon Construction at the Circuit Clerk's storage unit site to discuss the construction of the facility. Com. Crutchfield indicated the roof should be on by February 24, the framing of the exterior stud walls would begin on February 27 and be finished by March 9.

Commissioners received a call from Septagon to reserve a booth for the Northeast Missouri Commission and County Clerk's Conference on March 15.

Com. Carter received a call from Ron Watts, MODOT, to make revisions to the BRO application for CR 2580 KCS Railroad bridge replacement project.

Com. Crutchfield reported on his conversation with Larry Prather concerning improvements on CR 1395. Mr. Prather indicated he would send a check for purchase of new culverts in the next week.

11:30 a.m. Com Wilcox called to check in.

Commissioners reviewed invoices for payment. Following review, Com. Crutchfield made a motion to approve payments as presented. Com. Carter seconded, motion passed (2-0), and checks were signed.

Com. Carter contacted Chariton County Clerk Susan Littleton with information concerning Randolph County's Road and Bridge Department Road Policies and Standards as requested by Chariton County Commissioners.

1:00 p.m. Road and Bridge Supervisor Mike Rogers arrived to discuss a complaint from Bob Kern regarding his fence along CR 2905.

Commissioners reviewed minutes from February 21, 2012. Following review, Com. Crutchfield made a motion to approve these minutes. Com. Carter seconded and motion passed (2-0).

911 Coordinator Joan Joseph and County Clerk Will Ellis arrived to discuss the Northeast Missouri Association of Commissioners and Clerk's Conference on March 15, 2012.

Commissioners handled correspondence.

4:00 p.m. Meeting was adjourned.


