

**RANDOLPH COUNTY COMMISSION MINUTES**

**Tuesday, July 10, 2012**

The Honorable Commission convened at the Huntsville Courthouse with the following present: Susan Carter, Presiding Commissioner; Jerry Crutchfield, Western District Commissioner; and Shelby Creed, Deputy Clerk. Wayne Wilcox, Eastern District Commissioner was absent.

**9:00 a.m.** Com. Carter called the meeting to order and moved approval of the agenda. Com. Crutchfield seconded and motion passed (2-0).

County Clerk Will Ellis arrived to report that he received a call from a resident concerning a county road sign on the corner of CR 2565 and CR 2560 that was down. Clerk Ellis indicated he contacted the Road and Bridge Department and someone will be installing a new sign. Clerk Ellis also reported on his meeting with Charlie Zitnik, DA Davidson, concerning refinancing the county's Justice Center bonds.

Commissioners reviewed invoices for payment. Following review, Com. Crutchfield made a motion to approve payments as presented. Com. Carter seconded, motion passed (2-0), and checks were signed.

Commissioners reviewed payment of Jury Script. Following review, Com. Crutchfield made a motion to approve payments as presented. Com. Carter seconded, motion passed (2-0), and checks were signed.

Com. Crutchfield contacted Circuit Clerk Peggy Boots to discuss the door sticking at the new Circuit Clerk's storage building. It was determined the problem was due to the excessive heat. Mrs. Boots also reported she obtained an additional discount for the county for purchase of storage shelves in the unit.

**11:00 a.m.** Road and Bridge Supervisor Mike Rogers arrived to discuss road maintenance issues. Also discussed were road and bridge employees moving records for the Randolph County Coroner. Mike Rogers reported that the Road and Bridge Department was going to replace one piece of siding for Bill Gibson that was damaged during brush hogging operation. Mike Rogers reported that he painted county right-of-way along CR 2445 at Sweet Springs Church.

Commissioners reviewed minutes from July 3, 2012. Following review, Com. Crutchfield made a motion to approve these minutes. Com. Carter seconded and motion passed (2-0).

**12:30 p.m.** Com. Wilcox joined the meeting by speakerphone. Com. Carter recessed the regular meeting and convened the 2012 Randolph County Board of Equalization. Com. Crutchfield nominated Com. Wilcox as Chairman. Com. Carter seconded and motion passed (3-0). Chairman Wilcox recessed the Board of Equalization. Com. Carter reconvened the regular meeting.


Commissioners signed official minutes from June 21, 2012 and June 28, 2012.




Commissioners handled correspondence.


